With the application of this licence, the licence must be okay. The licence shall at this evidence-which form the limitation of liability is explained and information on the available insurance-by agreement to sign.

## Liability and Insurance

### Liability

The KNMV is a non-profit organisation, which is already more than 100 years of effort in order to enable its members to make their hobby - Motorsport-in a responsible manner to be able to exercise.

The applicant for a license from the KNMV should be aware of the risks, both for him / her as a third party, associated with the Exercise of motorsport. Unfortunately, collisions and other accidents with some regularity. The risk of accidents is inextricably linked to participate in the motorsport. By signing this form, the applicant for the license that he is familiar with this risk and accept this risk and for their own account.

By signing, the applicant further agree that the KNMV not accept responsibility for the damage Licensee. This is partly for personal injury case in which the licensee suffer during or as a result of participation in events without a nature of contest, training, and / or competitions, or so the preparations taking place under the auspices of the KNMV. KNMV will not rely on this exoneratieclausule if the damage of the licensee is the result of willful misconduct or gross negligence of the KNMV or with the leadership of the KNMV persons. Licensees can also damage in the event of other participants in events without a nature of contest, training, and / or competitions or officials, Organizers, employees or board members of the KNMV not liable for damage arising from participation in these events without a game character, training and / or competitions, including the preparation thereof, subject to willful misconduct or gross negligence on the part of those persons.

### Insurance

This indicates that participation in the motorsport the necessary risks to produce. KNMV has for all its licences two insurance completed: a liability and accident insurance.

### ATTENTION:

As both insurance a number of important limitations and conditions, it is important that you take the following well-read.

### Liability insurance

The KNMV liability applies only to:

1. Events without a game character, competitions and related training under the auspices of the KNMV be performance in the Netherlands and which your license, the KNMV gives you permission to participate, and
2. Free training by KNMV licensees in the Netherlands by the KNMV recognized circuits.

Furthermore: making free training abroad is not insured against liability.

The liability insurance covers the liability of the licensee for injury (injuries and damage) during events without Wedstrijdkarakter, competitions, the corresponding training and free training. The insurance covers include any liability Spectators for an amount of € 1.250.000, --. There is a risk of its own at least € 1.000, - for damage and € 5.000, - for personal injury.

***(On their own risk for personal injury will be forwarded to the licensee up to € 500, - as their own risk cost.***

***Provided that there is no gross negligence or intent.)***

This insurance also contains a number of (by the market inevitably) restrictions. These include (1) is excluded damage being inflicted on Vehicles other participating or are intended to participate in the competitions or training, and (2) harm to other persons who Participate in the competitions or training. It also provides insurance excludes coverage for damage to the circuit of the trail out. The policy of this insurance are available for inspection at the Secretariat of the KNMV in Arnhem.

### Accident insurance

This is already indicated that the risk that you suffer personal injury case or during or as a result of the exercise of motorsport for your own And risk taking. The KNMV, in the event that you suffer unexpected damage itself, a personal accident insurance. This insurance will at death as a result of an accident while participating in a training or competition of the licensee a sum of € 5.000, - and at full permanent disability as a result of an accident during training or participation in a contest under the auspices of the KNMV of the licensee an amount not exceeding € 25.000, -. The policy of this insurance are available for inspection at the Secretariat of the KNMV in Arnhem.

The KNMV accident insurance is only applicable to:

1. Match character without events, competitions and related training under the auspices of the KNMV be inNederland performance in which your license, the KNMV gives you permission to participate, and
3. free training by KNMV licences (including districtlicentiehouders provided Dutch resident) in the Netherlands by the KNMV recognized circuits.

To participate of free traning in abroad is not insured, there for you need a special insurance.

KNMV stresses that this insurance is not health insurance. You should review to take care. The accident insurance applies only to KNMV licensees. For District license holders case, they must be Dutch resident.
